





Information on the processing of personal data of customers

Pursuant to articles 13 and 14 of Regulation 2016/679 / EU (hereafter "GDPR") CO.Plast srl (hereinafter "Owner") Via Provinciale La Santa, 7 - 23890 - Bevera di Barzago, in its capacity as "Data Controller", Informs you that your personal data collected for the purpose of concluding the contract with the customer and / or in the context of execution and / or stipulation of the same will be treated in compliance with the aforementioned regulations, in order to guarantee the rights, liberties fundamental rights, as well as the dignity of natural persons, with particular reference to privacy and personal identity. We inform you that if the activities provided to you provide for the processing of personal data of third parties in your ownership it will be your responsibility to ensure that you have complied with the provisions of the law in respect of the subjects concerned in order to make their treatment legitimate on our part.

Origin, purpose, legal basis and nature of the data processed

The processing of your personal data, directly supplied by you, is carried out by CO.Plast srl for the purpose of concluding the contract with the Customer and / or in the context of execution and / or stipulation of the same.

Also, the processing of personal data of third parties communicated by the Customer to the Company is possible. With respect to this hypothesis, the Customer acts as autonomous data controller and assumes the consequent legal obligations and responsibilities, relieving the Company from any objection, claim and / or request for compensation for the damage caused by treatment that should reach the Company from third parties. concerned.

In compliance with the current legislation on the protection of personal data and without the need for specific consent from the Data Subject, the Data will be stored, collected and processed by the Company for the following purposes:

- a) fulfilment of contractual obligations, execution and / or conclusion of the contract with the Customer and / or management of any pre-contractual measures;
- b) fulfilment of any legal obligations, tax and fiscal provisions deriving from the performance of the business activity and obligations related to administrative and accounting activities;
- sending, directly or through third parties, marketing and communication service providers, newsletters and communications for direct marketing purposes through e-mail, text messages, mms, push notifications, faxes, paper mail, telephone with operator;
- d) communication of data to third parties for the sending of newsletters and communications for marketing purposes through e-mail, sms, mms, push notifications, fax, paper mail, telephone with operator.

The legal bases of processing for the purposes a) and b) above are the articles. 6.1.b) and 6.1.c) of the Regulations.

The provision of data for the aforementioned purposes is optional, but any failure to provide the data and the refusal to supply them would make it impossible for the Company to execute and / or stipulate the contract and provide the services requested by the same.

The legal basis for the processing of personal data for the purposes c) and d) is art. 6.1.a) of the GDPR as the processing is based on consent; it is specified that the Data Controller may collect a single consent for the marketing purposes described herein, in accordance with the General Provision of the Guarantor for the protection of personal data "Guidelines on promotional activities and the fight against spam" of 4 July 2013. The giving consent to the use of data for marketing purposes is optional and if the interested party wishes to oppose the processing of data for marketing purposes performed with the means indicated herein, as well as revoke the consent given, may at any time do so without no consequences (except for the

fact that you will no longer receive marketing communications) by following the instructions in the "Rights of Interest" section of this Notice.

Lastly, it was noted that for the processing carried out for the purpose of sending direct advertising material or direct sales or for carrying out market research or commercial communications in relation to products or services similar to those used by the Customer, the Company can use the e-mail addresses or personal data according to and within the limits allowed by the art. 130, paragraph 4 of the Privacy Code (Legislative Decree No. 196/2003) and the provision of the Authority for the protection of personal data of June 19, 2008 even in the absence of explicit consent. The legal basis of data processing for this purpose is art. 6, paragraph 1, lett. f) of the GDPR, without prejudice to the possibility of opposing this treatment at any time, following the instructions in the "Rights of the Interested" section of this Notice.

Communication

The data may be disclosed to third parties appointed as data processors in accordance with article 28 of the GDPR and in particular to banks, to companies active in the insurance field, to service providers strictly necessary for carrying out the business activity, or to consultants of the company, where this is necessary for fiscal, administrative, contractual or for reasons protected by current regulations.

Your personal data, or the personal data of third parties in its ownership, may also be disclosed to external companies, identified from time to time, which CO.Plast srl entrusts the execution of obligations arising from the assignment received to which they will be transmitted only data necessary for the activities requested by them. All employees, consultants, temporary workers and / or any other "natural person" who carry out their activities on the basis of the instructions received from CO.Plast srl, pursuant to art. 29 of the GDPR, are appointed "persons in charge of processing" (hereinafter also "persons in charge"). To the persons in charge or to the Managers, possibly designated, CO.Plast srl gives appropriate operative instructions, with particular reference to the adoption and compliance with security measures, in order to guarantee the confidentiality and security of data. Precisely with reference to the personal data protection aspects, the Customer is invited, pursuant to art. 33 of the GDPR to report to CO.Plast srl any circumstances or events from which a potential "breach of personal data (data breach)" may occur in order to allow an immediate evaluation and the adoption of any actions aimed at countering such event by sending a communication to CO.Plast srl at the addresses indicated below.

Data will not be disclosed.

The obligation of CO.Plast srl to communicate the data to Public Authorities on specific request remains unchanged.

Transfer abroad

The transfer of your personal data abroad may occur if it is necessary for the management of the assignment received. For the treatment of the information and data that will be eventually communicated to these subjects will be required the equivalent levels of protection adopted for the processing of personal data of its employees. In any case, only the data necessary for the achievement of the intended purposes will be communicated and the regulatory instruments provided for by Chapter V of the GDPR will be applied.

Methods, treatment logics and storage times

Your data are collected and registered in a lawful and correct manner for the purposes indicated above in compliance with the principles and provisions of art. 5 c 1 of the GDPR.

The processing of personal data is done by manual, computerized and telematic tools with logic strictly related to the purposes themselves and, in any case, in order to guarantee their security and confidentiality.

Personal data will be processed by CO.Plast srl for the duration of the assignment and also subsequently to assert or protect its rights or for administrative purposes and / or to fulfil obligations arising from the regulatory and regulatory framework pro tempore applicable and in compliance with the specific data retention law obligations.

Nature of the conferment

In relation to the aforementioned purposes a) and b) above, the conferment of your data is essential for the execution of the assignment between you and CO.Plast srl and to allow CO.Plast srl to comply with the requirements of the applicable regulations: failure to provide the data and refusal to supply them would make it impossible for the Company to execute and / or stipulate the contract and provide the services requested by it. We inform you, therefore, that the processing of personal data takes place on the basis of the provisions of Article. 6 c. 1 b) of the GDPR.

It is instead optional to provide your personal data for the purposes c) and d) for which you can freely decide whether to give the specific consent that you can always revoke.

Rights of the interested party

In compliance with the limits and conditions established by the law regarding the protection of personal data concerning the exercise of the rights of the interested parties [1] with regard to the processing covered by this Privacy Policy, as an Interested Party you have the right to request confirmation that your personal data is being processed, access personal data concerning you and in relation to them the right to request rectification, cancellation, notification of corrections and cancellations to those who may have been transmitted by our Organization, limitation of treatment in the cases envisaged by the law, the portability of personal data - provided by you - in cases indicated by the law, to oppose the processing of your data and, specifically, has the right to object to decisions concerning him if based solely on automated processing of his data, including profiling. In the event that you believe that the treatments that affect you violate the rules of the GDPR, you have the right to lodge a complaint with the Guarantor pursuant to art. 77 of the GDPR.
